10 Year Mechanical Warranty

Tychi Systems, Inc. extends a 10 Year Mechanical warranty to the original consumer purchaser that each of Tychi's Flex Series (Flex 100-400M) products against defects in material and workmanship as long as the original consumer purchaser owns the product. Upon return of a defective Product to the Company, the Company shall either repair the product or replace the product at no charge for parts and labor.

Finish Warranty

Tychi Systems, Inc. extends a full 5-year warranty to the original consumer purchaser that each of Tychi's Flex Series (Flex 100-400M) products of a 5-year Durable Finish in brass (or gold color) and chrome (silver color) finishes against tarnishing as long as the original consumer purchaser owns the product. Upon return of a defective Product to the Company, the Company shall either repair the product or replace the product at no charge for parts and labor.

To obtain warranty service, the lock must be returned within the warranty period. Pack the lock in its original box or properly insulated to avoid shipping damage. Shipping damages are not included in the product warranty and must be recovered from the shipper. Include a letter detailing symptoms of the problem, a day time phone number and email address.

In addition to shipping damage, this Warranty does not cover defects or malfunctions resulting from abuse, misuse, unauthorized modifications, tampering, accidental breakage, acts of God or operation on incorrect power supplies.
